Paris 2024 – Slot Redistribution

Dear colleagues,

As you are aware, any qualification slot to the Paris 2024 Paralympic Games (the **Games**) which is returned by the respective NPC or IF after the deadline for final confirmation returns to the IPC for redistribution at our sole discretion (see Qualification Regulations, page 9).

Today I have the pleasure to offer your NPC a vacant qualification slot for the following athlete (the **Athlete**):

This redistribution is made by the IPC in its sole discretion and may be revoked at any time, including if the Athlete fails to meet any of the criteria below.

Please note that this redistribution is subject to the terms and conditions of the Paris 2024 Paralympic Games Qualification Regulations (the **Regulations**) and the rules and regulations of World Archery (as the international federation for the Athlete's sport). As a reminder in this respect, the Athlete **must**:

- **by the Sport Entries deadline of 5 August 2024**, fulfil all the criteria contained in the general IPC regulations on eligibility for the Games set out in the Regulations, including with respect to the Athlete's classification sport class status;
- **by the Sport Entries deadline of 5 August 2024**, comply with the classification eligibility requirements of World Archery. Please note the

Athlete is only eligible to compete in the event(s) listed above and must hold an eligible sport class for the event(s);

- **by the Sport Entries deadline of 5 August 2024**, meet all of World Archery's other sport-specific eligibility criteria set out in the Regulations; and
- be on the Accreditation Long List for the Games. **Deadline for submission of accreditation applications to Paris 2024 was 3 May 2024**. Please consult with your Regional NPC Services Coordinator at Paris 2024 to resolve any accreditation issues.

The online Sport Entries system for the Games **opened on 1 July 2024**, and it is your responsibility to process the Athlete's entry. Please contact your Regional NPC Services Coordinator at Paris 2024 with any questions.

We understand that you have already confirmed acceptance of this redistribution slot to World Archery but please notify us immediately should you decide to decline the offer. Thank you!
